


A. The purpose of this modification is to:

1. Administratively change Part B-2 to reflect changes that were made in Paragraph 14.B.2. of Modification P00072, yet inadvertently omitted from that modification's replacement Part B-2. The numbering of SLINs X028AE, X028AF, X028AG and X028AH is changed to: X029YA, X029YB, X029YC and X029YD, respectively.

2. Administratively change Part B-2, by changing the descriptions of SLINs X001YC and X001YJ. SLIN X001YC is changed from "PDCT 8146 Communication Docking Station/Battery Charger," to read "PDCT F Class Communication Docking Station/Battery Charger." SLIN X001YJ is changed from "PDT 8146 Class, High Capacity, Rechargeable Battery," to read "PDT F Class, High Capacity, Rechargeable Battery."

3. Incorporate Symbol Technologies Inc.'s Contract Change Proposal 0101 (CCP-0101) to add the PDT 8100 Class PDCT-F1CX with a keyboard and touchscreen, 1/4" VGA, color, programmable, portable data collection tool.

3. Symbol shall, in a future CCP(s), provide a Software Development Kit to support application generation utilizing Type II and Type III contact memory devices and Application Development Generation Software as well as any other necessary items in order to make the PDT 8100 Terminal fully operational in accordance with Specification paragraph 3.10.

C. Part D-1, Statement of Work and Specifications, is modified as follows:

Paragraphs 4.18.1.1, and 4.18.1.2 are added as follows:

**4.18.1.1 PDCT-F1CX, COLOR PDCT, WITH INTEGRAL 1D SCANNER.**

The Contractor shall provide a ruggedized, programmable PDCT with an integral 1D linear bar code scanner. The integral 1D bar code scanner of the PDCT-F1CX shall scan low to high-density linear bar codes listed in the paragraph entitled "Bar Code Symbologies". The integral 1D bar code scanner shall have a depth of field of at least 4 inches for low and medium density bar codes and 2 inches for high density bar codes (These are not minimum read distances) and shall be capable of reading a minimum print quality of grade C bar codes in accordance with ANSI ASCX3.182-1990 (R1995).

**4.18.1.2 SEPARATELY ORDERABLE COMPONENTS.**

The Contractor shall provide the following Separately Orderable Components for the PDCT-F1CX:

- a. Communication Docking Station/Battery Charger;
- b. Multiple Battery Charger;
- c. Rechargeable Battery.
