


A. The purpose of this modification is to extend the ordering period for an additional 45 days, from 1 January 2003 through 14 February 2003, or until the "Notice to Proceed" is issued for the follow-on RFID-II contract, whichever is earlier.

B. Part C-1-1, paragraphs (a), (e), and (t), are revised as follows:

FROM:

(a) **Contract Life.** The total contract life, subject to exercise of FAR Clause 52.217-9, Option to Extend the Term of the Contract, is 64 months from the date specified in the written notice to proceed. The terms of the contract are:

OPTION YEAR 5: 1 October 2001 through 31 December 2002

TO:

(a) **Contract Life.** The total contract life, subject to exercise of FAR Clause 52.217-9, Option to Extend the Term of the Contract, is **65 months and 15 days** from the date specified in the written notice to proceed. The terms of the contract are:

OPTION YEAR 5: 1 October 2001 through **14 February 2002**

NOTE: Notwithstanding the changes to the Clauses shown above, the contract is extended to 14 February 2003 or until the "Notice to Proceed" is issued for the follow-on RFID-II contract, whichever is earlier.
